LIDDA nih tawrelpiak le bawmhnaak tampi a pek, cu hna cu:

- ◆ **Luhnak le minkhumhnak:** Tawrelpiaknak le bawmhnaak konglam peknak, IDD tawrelpiaknak tahfung na fa nih a tlinh le tlinh lo zohnak, chungkhar tangka lut tenpinak (SSI) kong bawmhnaak, pumtamtling lo zatlang bawmhnaak (SSDI), le Medicaid
- ◆ **Tawrelpiaknak tlaitu:** Sii-ai lei bawmhnaak ah chungkhar bawmhnaak, fim cawnnak, le zatlang tawrelpiaknak le bawmhnaak
- ◆ **Respite care:** Zohkhenak tawreltu (primary caregiver) aa manh lo caan ah caan-tawi bawmhnaak kong
- ◆ **Pumpak herhmi zohchih in bawmhnaak pekmi:** Rian kong bawmhnaak tawrelpiaknak, naarsing lei, thlopbulnak, le a hlei in bawmhnaak. Hi tawrelpiaknak hi a hmunhma hoih in aa dang lai.
- ◆ **Medicaid prok-rem:** Medicaid luh dingah min pekpiaknak le tahfung a tlingmi cu Medicaid prok-rem ah luhternak



Medicaid Waiver Prok-rem

Texas nih Medicaid waiver prok-rem phphun cu pumtlamtling cu mibu chungah an i tel ve khawhnak hnga tawltrepiaknak le bawmhna an pek. Prok-rem pakhat cio nih an pekmi tawltrepiaknak le bawmhna aa dang cio i, amah le ningcang cio an nei. Na fa tulio le hmailei a dirhmun cun, a tha thawhnak le bawmhna herhmi zohchih in zeibantuk bawmhna dah a herh timi kha LIDDA nih an bawmh khawh.

“Hngahmi (Interest List)” timi cu zeidah asi?

Hngahmi (interest list) timi cu phudang ding Waiting List ti zongah auh asi. A ra hmasami tawltrepiak hmasa tiin an tawltre ko. Na min kha a cung bik a phak cang ahcun Health and Human Services Commission (HHSC) siloah LIDDA ai-awhtu nih an rak in pehtlaih lai. Tangka thazaang hoih in hmunhma hi a lawng tawn i, hngahmi (Waiting List) ah a kum zongin um khawh asi.

Abiapimi Theih Ding:

- ◆ Na fa cu pum tlamtling lo asi ti na theih bakin amah cu Medicaid waiver prok-rem ah hngaktu (waiting list) ah hei chia colh (cahmai 3 nak zoh). Hmailei ah tawltrepiaknak na herh lo ahcun zeitik poh ah an letthan khawh peng.
- ◆ Hngaktu (waiting list) min peknak ah pum tlamtling lo sinak fehternak a herh lo.
- ◆ Pehtlaih duh tikah pehtlaih khawh dingin na pehtlaihnak kha tharchuah peng.
- ◆ Na fa dirhmun kha kum tiin chek lengmang. Na fa chuah nithla zong chek lengmang kha na tuah ding asi.
